

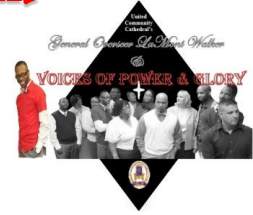

FACT SHEET

This fact sheet has been created to answer frequently asked questions regarding booking requests for General Overseer LaMont Walker & Voices of Power and Glory. Please review it carefully **prior** to completing the questionnaire form for booking. Please feel free to call our office if you have further questions.

WHAT ACCOMODATIONS ARE REQUIRED?

The following **ACCOMODATION REQUIREMENTS** are in effect for all requests held in locations which are outside of the Columbia area. These requirements are in order to facilitate the effectiveness of General Overseer Walker & V.P.A.G.'s ministry. Please review them carefully:

- A. The sponsoring organization must pay for lodging and travel arrangements. These arrangements are required for the following individuals, according to the ministry requested:

- B. These costs are **not** included in the consultation fee/honorarium.
- C. All lodging and travel arrangements will be approved by General Overseer Walker prior to booking.

WHAT IS THE CONSULTATION FEE/HONORARIUM?

When calculating your proposed compensation amount, please determine an amount which:

- A. Take into account the hours of consultation, instructions, and preparation time.
- B. Take into account the number of miles for travel, days of requested ministry, & hours of preparation.
- C. Matches the caliber of General Overseer Walker & V.P.A.G.'s work.
- D. Is *separate from lodging and travel expenses*.

(FAQs)

<i>Is a deposit required?</i>	<i>Yes. A 50% deposit of the consultation fee/honorarium is required approximately within 10 business days after receipt of the Ministry Agreement. This secures the requested calendar date.</i>
<i>What is a Technical Rider?</i>	<i>A technical rider provides detailed info on all equipment that is required when G.O. Walker and/or V.P.A.G. ministers – such as keyboards, mics, amplifiers, etc.</i>
<i>Can the ministry/organization record G.O. Walker and/or V.P.A.G.'s ministry?</i>	<i>Yes. The ministry/organization must provide G.O. Walker and/or V.P.A.G. with a copy of the recording in all formats created. Otherwise, the ministry/organization will not be permitted to record the ministry.</i>
<i>What happens to the deposit in the event of cancellation?</i>	<i>In the event of an Act of God, war, illness, or force majeure on the part of G.O. Walker and /or V.P.A.G. or the requesting ministry/organization, all advanced monies and/or deposits submitted shall be subjected to a full refund. In the event of cancellation by the ministry/organization within 30 days prior to the scheduled engagement, all monies/deposits issued will be forfeited to G.O. Walker and/or V.P.A.G. for compensation of lost engagement. In the event of cancellation by G.O. Walker and/or V.P.A.G. within 30 days of the scheduled engagement, all monies/deposits will be returned in full to the ministry/organization.</i>
